Official communication with Parties and observers

Note by the Secretariat

I. Introduction

1. The present document describes the existing routes of official communications between Parties, observers and the Secretariat under the Stockholm Convention, provides an opportunity for Parties to review the existing lists of contacts for those communications and suggests possible options for improving communication during meetings of the Conference of the Parties and during intersessional periods. The options suggested are based on the review of the activities needed for an efficient implementation of the Convention, the practice of other multilateral environmental agreements and the common practice of the United Nations.

2. The document consists of three parts: official communication with Parties; communication with and representation of observers; and possible action by the Conference of the Parties. The second part, on observers, is divided into three sections, each relevant to a group of observers as identified in Article 19, paragraph 8, of the Convention or rules 6 and 7 of the rules of procedure of the Conference. These groups are: States not Parties; the United Nations and its specialized agencies, the International Atomic Energy Agency (IAEA) and the Global Environment Facility (GEF); and national and international governmental and non-governmental bodies and agencies.

II. Official communication with Parties

3. Several provisions of the Stockholm Convention require the exchange of official information between Parties, between Parties and States that are not Parties, and between Parties and the Secretariat. These provisions are found, for example, in Article 3, paragraph 2 (b) (iii) (annual certification scheme with States not Parties); Article 4, paragraphs 3, 6 and 8 (notification, extension and withdrawal of specific exemptions); Article 5, subparagraph (a) (submission of action plans on releases); Article 7,

paragraph 1 (transmittal of implementation plans); Article 8, paragraphs 1, 4 (b), 5, 6, 7 and 8 (submission of proposals for listing of chemicals in Annexes A and B, and exchange of information relevant to the proposals); and Article 15, paragraph 2 (provision of information to the Secretariat).

4. Pursuant to paragraphs 1–3 of Article 9, Parties shall facilitate or undertake the exchange of information relevant to the reduction or elimination of the production, use and release of persistent organic pollutants (POPs) and on alternatives to them. Under paragraph 3 of Article 9, Parties shall designate national focal points for the exchange of such information. As set forth in paragraph 2 of that article, Parties may exchange that information directly or through the Secretariat.

5. Working arrangements for the implementation of the Convention also require the exchange of official information between Parties and between Parties and the Secretariat. Those arrangements may be related to nomination of participants in subsidiary bodies under the Convention in accordance with their terms of reference, provision of information related to a non-compliance regime, communication under the financial rules adopted by the Conference and other financial matters, and also all other types of official communications where official positions of Parties are stated.

6. During the negotiation of the Convention, in the interim period of its implementation and until the present the Secretariat has relied on the lists of United Nations Environment Programme (UNEP) official contact points in Governments as official accredited sources of information from countries. These lists are provided by the Secretariat on request.

7. The practice of other multilateral environmental agreements indicates that Parties nominate national contact points for the purposes of the multilateral environmental agreement in question to liaise with other Parties and the Secretariat on various aspects of the implementation of the multilateral environmental agreement and to assist in intersessional work. For example, Parties to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) nominate management authorities and scientific authorities; Parties to the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal nominate competent authorities and focal points; Parties to the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, Particularly in Africa nominate focal points; and Parties to the Convention on Biological Diversity nominate national competent authorities and national focal points.

8. For the efficient exchange of official information under the Stockholm Convention, it is important that each Party nominates:

(a) Official contact(s) for the performance of administrative functions under the Stockholm Convention and official communications other than information exchange under paragraphs 1 and 2 of Article 9 of the Convention; and

(b) National focal point(s) for the exchange of information under paragraphs 1–3 of Article 9 of the Convention.

III. Communication with and representation of observers

9. Concerning participation of observers in meetings of the Conference, Article 19, paragraph 8, of the Convention states that:

“The United Nations, its specialized agencies and the International Atomic Energy Agency, as well as any State not Party to this Convention, may be represented at meetings of the Conference of the Parties as observers. Any body or agency, whether national or international, governmental or non-governmental, qualified in matters covered by the Convention, and which has informed the Secretariat of its wish to be represented as meetings of the Conference of the Parties as an observer may be admitted unless at least one third of the Parties object.”

10. Rules 6 and 7 of the Rules of Procedure of the Conference of the Parties read as follows:

“Rule 6

1. The United Nations, its specialized agencies, the International Atomic Energy Agency, as well as any State not Party to the Convention, as well as any entity operating the mechanism referred to in paragraph 6 of Article 13 of the Convention, may be represented at meetings as observers.

2. Such observers may, upon invitation of the President, participate in the proceedings of any meeting without the right to vote, unless at least one third of the Parties present at the meeting object.

Rule 7

1. Any body or agency, whether national or international, governmental or non-governmental, which is qualified in matters covered by the Convention and which has informed the Secretariat of its wish to be represented at a meeting as an observer, may be so admitted, unless at least one third of the Parties present at the meeting object.

2. Such observers may, upon invitation of the President, participate without the right to vote in the proceedings of any meeting in matters of direct concern to the body or agency they represent, unless at least one third of the Parties present at the meeting object.”

11. During the intersessional period, observers are extensively involved in the implementation of Articles 8 and 9 of the Convention, and also in the work of subsidiary bodies of the Conference such as the Persistent Organic Pollutants Review Committee and the Expert Group on Best Available Techniques and Best Environmental Practices.

12. The following paragraphs cover issues relevant to the participation of observers in the implementation of the Convention during meetings of the Conference and during the intersessional period, divided into three sections in accordance with the groups of observers identified in Article 19, paragraph 8, of the Convention and rules 6 and 7 of the rules of procedure.

A. States not Parties

13. For this group of observers, it is suggested that the Secretariat should continue the practice of using the lists of UNEP official contact points for communicating with the States not Parties to the Convention on any matter pertaining to their observer status during meetings and the intersessional period. They participate in meeting of the Conference under Article 19, paragraph 8 of the Convention and rule 6 of the rules of procedure.

B. United Nations, its specialized agencies, IAEA and GEF

14. The list of addresses in the United Nations, its 15 specialized agencies, IAEA and GEF (which, on an interim basis, is the principal entity entrusted with the operation of the financial mechanism referred to in Article 13 of the Convention) is given in annex II to the present note. The list includes addresses which the Secretariat has extracted from the lists of UNEP official contact points for observers and addresses of the head offices of entities and their key divisions registered at the first meeting of the Conference of the Parties. Those observers constitute a definite group of international intergovernmental entities. They participate in meeting of the Conference under Article 19, paragraph 8, of the Convention and rule 6 of the rules of procedure.

C. National and international governmental and non-governmental bodies and agencies

15. These observers constitute an indefinite group of entities selected according to the criteria set forth in Article 19, paragraph 8, of the Convention and rule 7 of the rules of procedure. Under Article 19, paragraph 8, of the Convention, any such observer body or agency must be qualified in matters covered by the Convention and must inform the Secretariat of its wish to be represented at a meeting of the Conference of the Parties. It may participate in a meeting unless at least one third of the Parties present object.

16. Annex III to the present note contains a list of the bodies and agencies referred to above which expressed a wish to be represented at the first meeting of the Conference, which are qualified in matters of the Convention and for the participation of which no objection was expressed. Only names of entities are listed, without addresses, as accreditation refers to entities. The list is divided into two parts: part 1, intergovernmental organizations, and part 2, non-governmental organizations. The division is based on the differing approaches to accreditation of those entities in the United Nations system, and therefore the differing approaches which the Secretariat applied to their accreditation.

17. Part 1 of annex III of the present document contains a list of intergovernmental organizations which expressed a wish to be represented at the first meeting of the Conference, which are qualified in

matters of the Convention and for the participation of which no objection was expressed. Those entities customarily participate in United Nations meetings as observers in accordance with the applicable rules of procedure.

18. Part 2 of annex III of the present document contains a list of non-governmental organizations which expressed a wish to be represented at the first meeting of the Conference, which are qualified in matters of the Convention, to whose participation no objection has been expressed and which were accredited as observers at the first meeting of the Conference of the Parties. In preparing for the first meeting of the Conference, the Secretariat applied the Economic and Social Council rules, *mutatis mutandis*, to the accreditation requirements for non-governmental organizations before applying the rules of procedure.

19. In addition to the Economic and Social Council rules, screening criteria adopted under other multilateral environmental agreements, in particular criteria developed under UNCCD, were applied by the Secretariat to the information provided by non-governmental organizations when they were requesting accreditation at the first meeting of the Conference. Before the first meeting of the Conference of the Parties, the Secretariat invited those organizations to submit the information found in annex IV to the present document. That information was intended to confirm the legal personality of the organization and its qualifications in matters covered by the Convention. That information is available from the Secretariat should Parties wish to review it.

IV. Possible action by the Conference of the Parties

20. The Conference may wish:

(a) To invite Parties to nominate to the Secretariat of the Stockholm Convention official contact points for the performance of administrative functions and all formal communications under the Convention through their UNEP official contact points or their diplomatic representations;

(b) To approve, with any amendments which they may wish to make, the draft nomination form reproduced in annex I of the present note and encourage Parties to use the approved form for making their nominations pursuant to paragraph (a) above;

(c) To request the Secretariat to maintain and update as needed a list of official contact points and make it publicly available;

(d) To request the Secretariat to use the list, in annex II of the present note, of contacts in United Nations offices and specialized agencies, IAEA and GEF, with any amendments which they may wish to make, for the purposes of inviting observers to the meetings of the Conference of the Parties and its subsidiary bodies and for purposes of communication with observers during the intersessional periods of the Conference of the Parties and its subsidiary bodies;

(e) To request the Secretariat to use the list of national and international governmental and non-governmental bodies and agencies, in annex III to the present note, with any amendments which they may wish to make and as updated by each ordinary meeting of the Conference of the Parties, for the purposes of inviting observers to the meetings of the Conference of the Parties and its subsidiary bodies and for official communication during the intersessional periods of the Conference of the Parties and its subsidiary bodies;

(f) To agree to accredit to the meetings of the Conference the non-governmental organizations listed in part 2 of annex III of the present document, with any amendments which they may wish to make, and on the understanding that the Conference of the Parties may decide against the admission of these observers to any meeting of the Conference of the Parties and its subsidiary bodies pursuant to paragraph 8 of Article 19 of the Convention;

(g) To invite non-governmental organizations which are not included in the list contained in part 2 of annex III of the present document and wish to be accredited to the meetings of the Conference to submit the information listed in annex IV of the present note to the Secretariat at least 30 days before an ordinary meeting of the Conference of the Parties;

(h) To request the Secretariat to update the list of national and international governmental and non-governmental bodies and agencies after each ordinary meeting of the Conference of the Parties, starting with the second meeting of the Conference of the Parties, by including in the list those intergovernmental organizations which registered at that meeting and those non-governmental organizations which were accredited at that meeting.
